MILITARY SABBATH ON 10 November 2024 at 1100 HOURS by Tom O'Brien, BG (Ret), USA

The beautiful Holy Cross-Immaculata Church in Mt. Adams was built over a century and a half ago under the supervision of Bishop Fenwick. It is a lovely edifice adjacent to the Ohio River, and is famous as the church where Cincinnatians gather every Good Friday to "pray the steps". Since 1972 the Military Sabbath has been a hallmark of local Veterans Day activities. While our Chapter has been, in the past, a named sponsor (along with the Navy League as prime sponsor), this year we are a co-lead sponsor. The event is thus one of our official activities, and you are encouraged to attend. An Army Chaplain, the Elder Glee Club, and the Sea Scout Honor Guard will participate, and we will enjoy coffee and donuts following the ceremony. The singing of the Navy Hymn is always a highlight. While this service is officially a Catholic Mass, everyone is welcome and many veterans of other faiths attend. The wear of the appropriate service Class A uniform is encouraged but not required. Those members attending will gather outdoors and enter as a group during the processional. Please tell your veteran friends about this moving and traditional service. We look forward to seeing you there and joining us in worship, then fellowship at the social hour following the service.

Legislative Affairs by CAPT Alan Echt

Greetings, fellow members. I write today to encourage all of you to become engaged in the legislative process, and to give you steps to do so. Most of our Chapter's members live in three Ohio Congressional districts: OH-1, OH-2, and OH-8. OH-1 includes all of Warren County and the eastern part of Hamilton County. OH-2 consists of 15 counties in southern and southeastern Ohio: Adams, Brown, Clermont, Clinton, Gallia, Highland, Hocking, Jackson, Lawrence, Meigs, Pickaway, Pike, Ross, Scioto, and Vinton. OH-8 is made up of all of Butler, Darke and Preble Counties plus part of Miami and Hamilton Counties. OH-1 is represented by Congressman Greg Landsman, OH-2 is represented by Congressman Brad Wenstrup (an MOAA member), and OH-8 is represented by Congressman Warren Davidson. Congressman Wenstrup is not running for reelection in OH-2. One of our members, Orlando Sonza, is running against incumbent Greg Landsman for his congressional seat in OH-1 Two new candidates, David Taylor and Samantha Meadows, are running for the open OH-2 seat. And Vanessa Enoch is running against incumbent Warren Davidson. This MOAA chapter cannot give a political endorsement in these races, but encourages you to do your research and vote, keeping in mind the potential impact on the issues facing MOAA members and spouses.

In this month's column, I wanted to inform you about your Representative's sponsorship of a couple of MOAA's top priorities. The Major Richard Star Act (H.R. 1282) would allow Chapter 61 disability retirees to receive veterans' disability compensation and retired pay or combat-related special compensation. Introduced by Representative Gus M. Bilirakis, the bill has 326 cosponsors, including Rep. Landsman. Representatives Davidson and Wenstrup are not cosponsors of the bill (please see <u>https://www.congress.gov/bill/118th-congress/housebill/1282/cosponsors?pageSort=alphaByState</u> for an alphabetized list of cosponsors by state). According to MOAA, "The Senator Elizabeth Dole 21st Century Healthcare and Benefits Improvement Act addresses a <u>long list of MOAA's legislative priorities</u>, covering everything from assisted living services to caregiver benefit access to home-based care." Introduced by Representative Juan Ciscomani, the bill has 50 cosponsors, including Rep. Wenstrup. Representatives Davidson and Landsman are not cosponsors (please see
